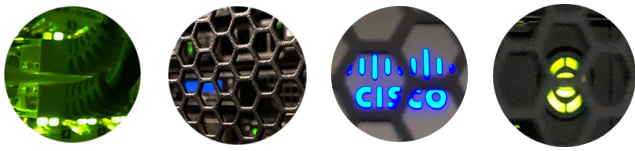

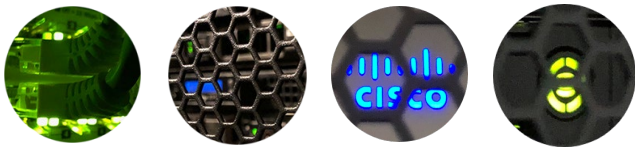

## **DEFINITIONS**

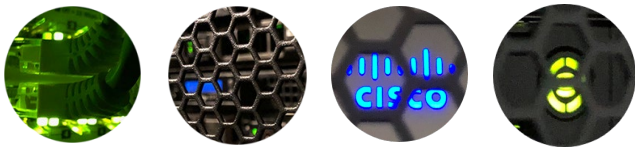
